### ATP Private Equity Partners announces an increase of ATP PEP Fund V to €1.5bn.

ATP Private Equity Partners, the private equity arm of ATP, announces a fund size increase of €0.7bn in ATP PEP Fund V, bringing the total fund size to €1.5bn. ATP, Denmark's largest pension fund with more than €100bn in assets under management, cements its long term commitment to the asset class increasing the size of Fund V to the same level as the prior ATP PEP funds.

"We are pleased with the backing from ATP and are looking forward to continuing our support of the existing fund managers in our portfolio in addition to proactively searching for new managers. In the most recent report from Preqin Performance Analyst, ATP PEP was again recognized as the "Most Consistent Performing Fund of Funds Manager" with four funds ranking in the top quartile. We believe this is a result of our disciplined investment process, the excellent relationship we have with both ATP and our GP's, and finally our strong teamwork", says Torben Vangstrup, Managing Partner at ATP PEP.

Fund V was launched in 2014 and has continued the same strategy as ATP PEP Funds I-IV. The €0.7bn increase allows ATP PEP to continue to invest within the global buyout, venture and distressed segments and to make co-investments with managers in the portfolio. ATP PEP's primary geographic focus will continue to be Europe and North America combined with select opportunities in other geographies.
